THE INNOVATOR

I am a Systems Development Accountant with many years of NHS experience in Management Accounts, Patient Level Costing, Efficiency and Benchmarking

THE PROBLEM

The Management Accounts team **needs to** engage with the budget holders using the most user-friendly and efficient outputs **because otherwise** they can become overwhelmed with documents and information which can lead to disengagement and a lack of control of the financial position.

THE CHALLENGE

How might we empower the budget holders **so that** they engage with the depth of financial information available and support them to identify waste reduction?

THE INNOVATION

Traditionally a budget holder has, on a monthly basis, received pdf budget reports, excel pivot tables with pay, excel pivots with non pay, transactional details, forecast file, savings targets and so forth. This can be overwhelming and can contribute to the disengagement with their finances/finance team due to the time required and the inflexibility to link all the files together to identify trends.

I was able to create an interactive dashboard which provides all the information in one place. It is user friendly and the end user can identify trends and switch the variables easily. All the data is interlinked so it provides a powerful tool, something which does not currently exist based on what I know. The dashboard is aesthetically pleasing and very comprehensive. What used to be numerous rigid data files per month for each area cost centre, now is in one place going back to the start of the prior financial year. This makes analysis simple and the end user is able to identify trends from a very high level to a granular level.

THE LESSONS LEARNT

- I wouldn't underestimate the time taken to get the formatting and layout because it is an important aspect and the time taken delayed the project slightly.
- I learned the importance of good quality source data. Initially when data quality was not as good, the outputs could not be as powerful as they are currently and data took longer to manipulate into the format I needed. The source data improvement journey led to better outcomes, a quicker dashboard and saves time in refreshing dashboards.

THE OUTPUTS

The tangible products that came from the innovation was:

- Easy to update files
- Detailed trend analysis
- Ease of use for end user

THE OUTCOMES

The benefits to the organisation because of the innovation as a result of the innovation were that less time was spent by Management Accounts putting together data from various sources. The budget holders are more willing to engage with their financial figures irrelevant of their level of understanding of finance. A lot of data is available in one place and makes extraction easier.

THE QUICK WINS

- Create a simple dashboard with just a trial balance and this can be grown on as experience with PowerBI increases.
- Layout and design is important
- Liaise with end users to identify what outputs they want
